#### ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation pursuant to Chapter 607, of the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

# **ARTICLE ONE**

The name of the corporation shall be

# **ARTICLE TWO**

This Corporation shall exist in perpetuity commencing on the date of the filing of these Afficles of Incorporation by the Secretary of State.
