ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF POWERHOUSE CONSTRUCTION & REMODELING INCORPORATED, INC.

Pursuant to the provisions of Chapter 607.1001 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is POWERHOUSE CONSTRUCTION & REMODELING INCORPORATED.
- 2. The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on March 4, 1997, in the manner prescribed by the Florida business Corporation Act:

"ARTICLE III: SHARES AND SHAREHOLDERS, is hereby amended to indicate that the corporation is authorized to issue 5,000 shares of class A common stock at \$1.00 par value.

3. The shareholders are not required to vote on the amendment to the Articles of Incorporation.
