ARTICLE ONE

The name of the corporation is **SMC ENTERPRISES, INC.** The principal address of the corporation is: 360 S.W. 66 Terrace, Margate, Florida 33068.

ARTICLE TWO

The period of its duration is perpetual.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
