**ARTICLES OF INCORPORATION
OF
MELROSE DEVELOPMENT CORPORATION**

The undersigned files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be **MELROSE DEVELOPMENT CORPORATION**. The existence of this corporation shall commence upon the filing of these Articles of Incorporation and shall continue perpetually unless dissolved according to law.
