ARTICLES OF INCORPORATION OF CAPITAL RECOVERY CORPORATION

ARTICLE I

97 FILED
TALLAMASSIE, IL ORIOA The name of the Corporation shall be CAPITAL RECOVERY CORPORATION.

ARTICLE II

This Corporation shall have perpetual existence.

ARTICLE III

This Corporation is formed for the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

The maximum number of shares of stock that this Corporation shall be authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock, of the par value of One (\$1.00) Dollar per share.

ARTICLE V

Every stockholder shall, on the sale for cash, of any new stock or authorized, but unissued, stock or treasury shares of the same class as that which he already holds, have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares), at the price at which it is offered to others.

ARTICLE VI
