


**ARTICLES OF INCORPORATION**

- I. The name of this Corporation shall be:  
South Eastern Association of Private Investigators, Inc.
- II. The specific purposes for which the corporation is organized are: to provide a means for licensed private investigators and agencies in the South Eastern United States to communicate and associate for professional, educational and social purposes, including computer and telephone communicating, meetings, informational and educational material, publications, ongoing and/or special projects for the good of the profession and the good of the public, and to engage in other activities which pursue these purposes. The corporation shall accept licensed private investigators, non-licensed professionals, and students (designated with a separate membership classifications) from states in the South Eastern United States as "members" and the interest and choices of members will generally determine activities, meetings and the alike; however members do not have an interest in corporation assets and do not have voting rights in corporation affairs.
- III. The corporation is authorized to issue 1000 shares of \$1.00 per value stock of only one class: common stock.
- IV. The address of the initial principal office, and also the initial registered office shall be:

- VII. The By-laws of the corporation shall provide for the selection of director and officers; and for managing the business and regulating the affairs of the corporation; and for defining, limiting, regulating and setting the fees for members.
- VIII. The corporation shall have all powers as provided by law.


