Enclosed please find the annual Uniform Business Reports for BLANDO PRODUCTIONS, INC. for the years 2000, 2001 and 2002. Also enclosed is our check in the amount of \$450.00 covering the charter renewal fee for these 3 years.

During a recent meeting with our accountant it was discovered that the renewal fee for 2000 and 2001 had not been paid. The reason for this is that we never received the UBR form for year 2000 and we (as a new corporation formed in 1999) were unaware of this renewal requirement. Our accountant determined the charter had been administratively dissolved in September, 2000 which would explain why we did not receive the UBR for 2001.

I contacted the Division of Corporations and spoke with a representative explaining that we had never received the 2000 form and were unaware of this fee, and she suggested I write this letter to request and abatement of the penalties, which I respectfully request.
