General Corporation Act, does hereby adopt the following articles of incorporations

### ARTICLEL

#### NAME OF CORPORATION

The name of the corporation is ROSAUTO, INC.

#### ARTICLEIL

#### **DURATION OF CORPORATION**

#### ARTICLEJY

#### **CAPITAL STOCK**

The corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending, or complete action, suit, or proceeding, whether civil or criminal, administrative or investigative, by reason of the fact that he or she is or was a director, officer, or employee of the corporation against expenses, including attorney's fees, judgments, fines, and amounts paid in connection with such action, suit, or proceeding, including any appeal thereof, if he or she acted in good faith or in a manner he or she reasonably believed to be in or not opposed to the best interest

of the corporation. With respect to any criminal action or proceeding, indemnification shall be made only if the director, officer or employee had no reasonable cause to believe his or her conduct was unlawful.

In addition to the indemnification provided for herein, the corporation shall have power to make any other or further indemnification, except an indemnification against gross negligence or willful misconduct.

#### ARTICLEIX

#### **YOTING RIGHTS**

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the issued and outstanding common shares.

#### ARTICLEX

#### **POWER TO CHANGE BYLAWS**

The power to make, alter, amend, and repeal the bylaws of the corporation shall be reserved to the shareholders of the corporation.
