**ARTICLES OF INCORPORATION
OF
M P PRODUCTIONS INC.**

THE UNDERSIGNED, have executed the following documents as incorporators of the above named corporation, a corporation organized under the law of the State of Florida, and all rights, duties and obligations of the undersigned incorporators, and those of the corporation, are to be determined with the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

M P PRODUCTIONS INC.

ARTICLE II

This corporation shall commence existence upon filing of those Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III

The general nature and purpose of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all the things therein mentioned, as fully and to the same extent as natural person might do. viz:

- 1) Transact any and all lawful business
- 2) Said corporation shall have further power:

To have perpetual succession by its corporate name;

To sue and be sued, complain and defend in its corporation name in all actions or proceedings;

To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced;

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all and any part of its properties and assets;
