#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the corporation is PRACTICAL AVIATION INC.

# ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate exist February 1, 1997.

### ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of airplane and componet parts sales.
- Totransact any other lawful business for which a corporation may be formed and allowed to do under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the aforegoing.

#### ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of \$ .01 per share.

## ARTICLE FIVE

The street address of the initial registered office and the principal office of the corporation is 10375 N.W. 2nd Street, Coral Springs, Florida 33071 and the name of its initial registered agent at such address is Hank Simpson. THIS IS ALSO THE ADDRESS OF THE INCORPORATOR. His signature as an incorporator accepts the designation as registered agent.

### ARTICLE SIX

#### ARTICLE EIGHT

Each stockholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the par value thereof, a pro rata portion of:

- 1. Any stock of any class that the corporation may issue or sell, whether or not exchangeable for any stock of . the corporation of any class or classes, whether or not of unissued shares authorized by the Articles of Incorporation as originally filed or by any amendment thereof or out of shares of the corporation acquired by it after the issuance thereof, and whether issued for cash, labor done, personal property or leases thereof: or
- 2. Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instrument or instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.

#### ARTICLE NINE

The affirmative vote of all shares of the corporation represented at a meeting which a quorum is present shall be required to amend these Articles so as to increase or decrease the authorized number of, or change the designations, preferences, qualifications, limitations, restrictions, or special or relative rights of any of the various classes of shares; or to merge or consolidate the corporation with or into any other corporation, or sell, lease, or convey all or substantially all of the assets of the corporation, or voluntarily to dissolve, liquidate or wind up its affairs.

I hereby am familiar with and accept the duties and responsibilities as registered agent for early corporation.
