NAME**

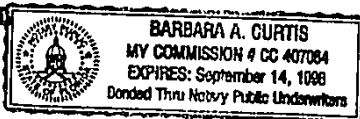

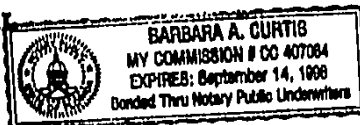
