**ARTICLE 1: NAME**

The name of this corporation shall be: **I Desire, Inc.**

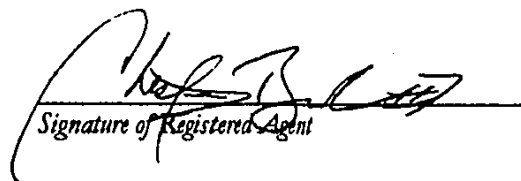
