

The undersigned subscriber to these Article of Incorporation, being a natural person competent to contract, hereby desire to form a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of this corporation shall be: SPEEDSTER RACING, INC.

ARTICLE TWO DURATION:

The corporation shall commence its existence upon the filing of the Articles of Incorporation with the Secretary of State and continue in perpetual existence unless sooner dissolved as provided by law.

ARTICLE THREE

The corporation may buy, sell, lease, rent, encumber, deal in or otherwise dispose of real or personal property including retail or wholesale sales, manufacturing, assembling, act as commission merchant, broker, jobber, dealer, import, export, or any other lawful business activity without limitation. To do any and all other acts and things as are necessary or convenient to the attainment of the purposes of this Corporation and any of them, to the same extent as natural persons lawfully might or could do in any part of the world, insofar as such acts are permitted to be done by a corporation organized under the Corporation Law of the State of Florida.

ARTICLE FOUR CAPITAL STOCK
