ARTICLES OF INCORPORATION

of

The undersigned hereby states, for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, immunities, and liabilities of corporation for profit, as follows:

ARTICLE I - NAME

The name of this corporation, (hereinafter referred to as the "Corporation") shall be:

DATA PLUS INVESTIGATIONS, INC.

ARTICLE II - PURPOSE

This Corporation is organized for the purposes of:

- A. Providing clients with a broad range of research and documentation services, including the acquisition of facts, information and data from all available sources, and including comprehensive public record and private sector information sources and including, but not limited to the subjects of, law, business, science, industry and education; and, to make such acquisitions through established, conventional research modes and through and including the most recent electronic data storage systems; and, to provide such retrieval services on a worldwide basis.

D. Further, however, this Corporation is organized for the purpose of transacting any or all other lawful business activities.
