ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PANDION SYSTEMS, INC. FILED 97 DEC 30 AM 8: 20 SECRETARY OF STATE TALLAHASSEE, FLORIDA

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is PANDION SYSTEMS, INC.

SECOND: Amendments adopted:

ARTICLE IV - CAPITAL STOCK is hereby deleted in its entirety and the following shall be inserted in lieu thereof:

"ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100,000 shares of \$1.00 par value common stock."

THIRD: The date of the Amendment's adoption is <u>SEPTEMBER 1</u>, 1997.

FOURTH: The foregoing Amendment was adopted by a Joint Written Consent of the Board of Directors and the Shareholders of the Corporation, in Lieu of a Special Meeting, executed by Shareholders holding a sufficient number of votes to cause approval of the foregoing Amendment and executed by all of the Directors of said Corporation on SEPTEMBER 1, 1997.
