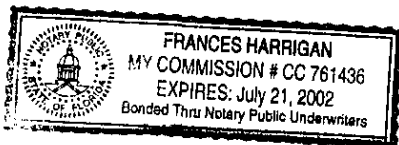
1. Mary Ann Sanger is the President of IT'S ACADEMIC, INC., a Florida corporation, (hereinafter "Corporation").
