THIS LETTER IS IN RESPONSE TO MY CONVERSATION WITH T. HAMPTON IN YOUR OFFICE. MR. HAMPTON EXPLAINED THAT OUR ANNUAL CORPORATE REPORT WAS NOT FILED IN 1998. HE ALSO EXPLAINED THE PROCESS TO REINSTATE AS AN ACTIVE CORPORATION AND THE COSTS INVOLVED. HOWEVER, IN EXPLAINING THE REASON FOR OUR FAILURE TO DO THE ANNUAL REPORT, HE SUGGESTED A LETTER TELLING THAT REASON AND ASKING FOR A REVIEW OF THIS CASE TO ELIMINATE THE REINSTATEMENT COST OF \$600.

WE AT TITLECORP OF FLORIDA HAD MOVED OUR OFFICE FROM ROCKLEDGE TO COCOA IN JULY OF 1997. SINCE THEN WE HAVE PERMANENTLY MOVED THAT OFFICE TO A MELBOURNE ADDRESS. IN EACH MOVE, WE HAVE NOTIFIED THE APPROPRIATE AGENCIES AND BUSINESS VENDORS INCLUDING OUR TITLE UNDERWRITER AND THE STATE OF FLORIDA. WE ALSO CONTINUED TO PAY MONTHLY PAYROLL TAXES AND FILED OUR CORPORATE RETURN FOR 1997 WITH THE NEW ADDRESS. IN ALL CASES, WE HAVE STAYED CONSISTENT WITHIN THE LEGAL STRUCTURE OF THE SYSTEM. WE HOWEVER NEVER RECEIVED THE CORPORATE REPORTING MATERIALS FROM THE STATE OF FLORIDA TO FILE ANNUALLY. QUITE SIMPLY, I DID NOT KNOW WE WERE SUPPOSED TO FILE SUCH FORMS OR WE WOULD HAVE DONE SO WITH THIS AS WELL AS ALL THE OTHER FORMS OF BUSINESS PAPERWORK TO STAY IN COMPLIANCE.

I HOPE YOU WILL SEE IT IN YOUR GRACES TO ELIMINATE THE FEE FOR REINSTATEMENT AND ACCEPT THE TWO YEARS OF ANNUAL COSTS THAT ARE ENCLOSED WITH THIS LETTER.
