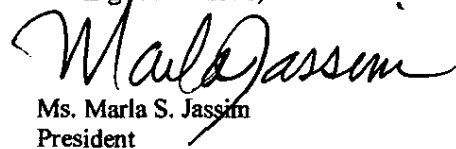
Dear Kathy,
