ARTICLES OF INCORPORATION

OF

NABO INVESTMENTS, INC.

ARTICLE I Name

The name of this corporation is $NABO\ INVESTMENTS$, INC, The principal office of the corporation is at $12352-89\ TERR$, N, SEMINOLE, FL, 33172

ARTICLE II Duration

This corporation shall exist perpetually unless dissolved according to law, commencing on the date of filing with the Secretry of State.

ARTICLE III Purpose
