#### Article I

The name of this corporation is Zions Group Corporation.

### Article II

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida, including but not limited to refinery, petroleum and finance.

#### Article III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.
