Article I - Name

EFFECTIVE DATE

The name of this corporation is FOUR STAR REALTY, INC.

#### Article II - Duration

This corporation shall have perpetual existence, commencing on JANUARY 24, 1997.

#### Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

## Article IV - Capital Stock
