THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby associates themselves together to form a corporation for profit under the laws of the State of Florida; and further does agree to the following conditions of said corporation:

#### ARTICLE I: NAME AND PRINCIPAL ADDRESS OF BUSINESS

#### ARTICLE II: NATURE OF BUSINESS
