THIRD ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF JND OF TAMPA, INC.

JND of Tampa, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

- The Original Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on January 29, 1997.
- 2. The Articles of Incorporation were amended on May 1, 1998 and May 29, 1998, changing the name of this Corporation.
- 3. This amendment to the Articles of Incorporation being effected hereby will completely delete Article FIRST of the Articles of Incorporation as of the date hereof, and substitute in its place the Article FIRST set forth below.
- 4. As amended below, Article FIRST of the Articles of Incorporation has the sole effect of changing the Corporation's name from "JND of Tampa, Inc." to "Ambassador Marketing, Inc.".
- 5. These amendments to the Articles of Incorporation were approved by unanimous written consent of the shareholders and board of directors, as of January 15, 1999.
- 6. These Articles of Amendment shall be effective immediately upon filing by the Secretary of State of the State of Florida, and thereafter, Article FIRST of the Articles of Incorporation shall read as follows:

FIRST: The name of the corporation will be **Ambassador Marketing, Inc.**
