ARTICLE I. CORPORATE NAME.

The name of this corporation is **ROYAL MAINTENANCE**, **INC**. and the principal place of business and mailing address of this corporation is 28100 U.S. 19 North, Suite 502, Clearwater, Florida 34621.

This corporation shall exist perpetually.
