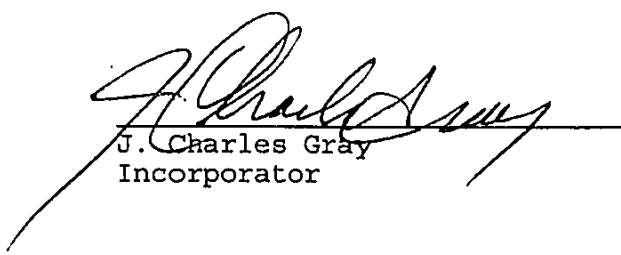
ARTICLE IX - BYLAWS

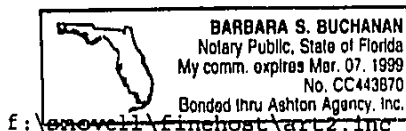

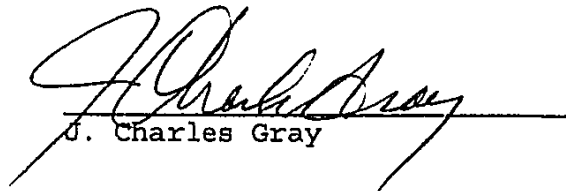
