THE UNDERSIGNED, desiring to incorporate a corporation under the provisions of the Florida Corporation Act does hereby certify:

1. The name of the corporation is BOUTSINA INTERNATIONAL, INC.

- 14. This articles shall be binding upon the parties hereto, their heirs, successors, assigns, and legal representatives.
