ARTICLES OF INCORPORATION OF DIAL A LAWYER, P.A.

A FLORIDA PROFESSIONAL SERVICE CORPORATION

PALLANIA SEE, PLORIDA The undersigned, acting as Incorporator of DIAL A LAWYER, P.A., a Florida Professional Service Corporation (the "Corporation"), pursuant to the laws of Florida, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Dial A Lawyer, P.A. and the street address of the initial principal office of the Corporation is 9800 SW 19th Street, Miami, Florida 33165.

ARTICLE II

PURPOSE

The Corporation is organized solely for the practice of law and such other activities as may be permitted by law.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue One Thousand (1,000) shares of One Cent (\$0.01) par value Common Stock.

ARTICLE IV

OUALIFICATIONS OF SHAREHOLDERS

All shareholders of the Corporation shall be persons duly licensed to practice law in the State of Florida. All shares of any shareholder who ceases to be so qualified shall be sold or transferred in accordance with the provisions of the Shareholders' Agreement to be entered into between the shareholders.

ARTICLE V

INITIAL BOARD OF DIRECTORS

The Corporation shall initially have two (2) Directors to hold office until their successor(s) shall have been duly elected and qualified at the first Annual Meeting of Shareholders or until their earlier resignation, removal from office or death. The number of Directors may be either increased or decreased from time to time in accordance with the Bylaws of the Corporation, but shall never be fewer than one (1).
