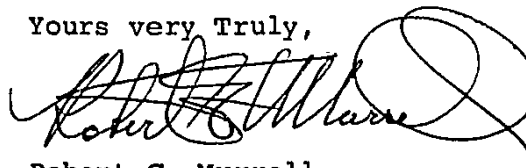

ARTICLE I  
NAME

The name of this corporation is ROBERT G. MURRELL, P.A.

ARTICLE II  
DURATION

This corporation shall have perpetual existence commencing on the date of filing these Articles with the Department of State.

ARTICLE III  
PURPOSE

The general nature and purpose of business to be transacted, promoted and carried on by the corporation are as follows:

- a) To engage in every aspect in the practice of law and all its fields of specialization, as are engaged in by attorneys.
- b) To engage in and render the professional services involved only through its officers, agents and employees who shall be lawyers in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- c) To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- d) To engage in no other business other than the rendition of the professional services specified herein.
- e) to do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto

which is not forbidden under the laws of the State of Florida. This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 621, Florida Statutes, as it now exists or may hereafter be amended.

**ARTICLE IV**  
**CAPITAL STOCK**

This corporation is authorized to issue Seventy Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock which shall be designated as the "Common Shares."

**ARTICLE V**  
**PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI**  
**PRINCIPAL PLACE OF BUSINESS; INITIAL REGISTERED OFFICE AND AGENT**

The street address of the principal place of business of the corporation is One North Rosalind Avenue, Orlando, Florida 32801. The initial registered office of this corporation is One North Rosalind Avenue, Orlando, Florida 32801, and the name of the initial registered agent of this corporation at that address is Robert G. Murrell.

**ARTICLE VII**  
**INITIAL BOARD OF DIRECTORS**

This corporation shall have an initial Board of Directors consisting of one (1) Directors. The number of Directors may be either increased or decreased from time to time by the by-laws. However, there shall never be less than one (1) Director nor more than five (5) Directors. The name and address of the members of the initial Board of Directors of the corporation are:

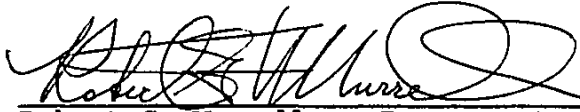
**ARTICLE IX**

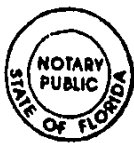
