The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

Articles I

The name of the corporation shall be Gospodarski & Company, Inc.

Articles II

Principal Office

The principal place of business of this corporation shall be 2160 Toco Terrace, St. Augustine, Florida 32092 and the mailing address of this corporation shall be P. O. Box 4022, St. Augustine, Florida 32085-4002.
