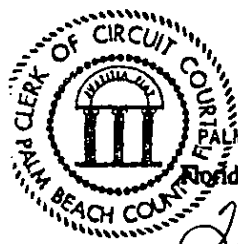
- This court has jurisdiction over the subject matter and the parties.
