ARTICLES OF INCORPORATION

FOR

ZOTECH PRODUCT SERVICES GROUP OF FLORIDA, INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: ZOTECH PRODUCT SERVICES GROUP OF FLORIDA, INC.

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

ARTICLE III. PURPOSE
