# ARTICLES OF INCORPORATION

0F

## RAPID PROMOTIONAL PRODUCTS, INC.



- 1. The name of the corporation is RAPID PROMOTIONAL PRODUCTS, INC. (the "Corporation").
- 2. Article I of the Articles of Incorporation of the Corporation is deleted in its entirety and a new Article I is hereby added to read as follows:
