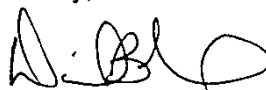

ARTICLE I.

NAME

The name of this corporation is Brooksville Plant, Inc.

ARTICLE II.

PRINCIPAL OFFICE

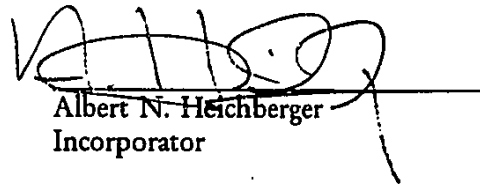
ARTICLE VII.

of Directors.

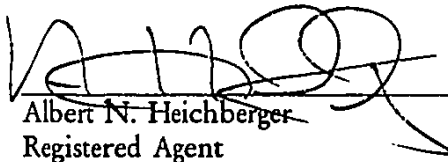
