ARTICLES OF INCORPORATION
OF

Common Cents Computer Service, Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby form a corporation under the laws of the state of Florida.

ARTICLE I

NAME:

The name of this corporation is: Common Cents Computer Service, Inc.

ARTICLE II

NATURE OF BUSINESS:

The general nature of business to be transacted by this corporation is:

(A) To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and Computer sales, service, support, repair, and other services of every kind, class, and description, except it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, telephone telegraph or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

(B) To conduct business in, and have one or more offices in, and buy, mortgage, hold, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida, and all other states and countries.

(C) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

(D) To purchase the corporate assets of any other corporation and engage in the same or other character of business.

(E) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while the owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
