ARTICLE I. - NAME

This corporation is organized for the purpose transacting any and all lawful business.

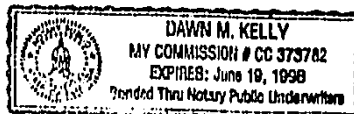


