ARTICLE ONE

The name of the corporation is **AFRICAN-AMERICAN BOUTIQUE AND BEAUTY SUPPLIES, INC.** The principal address of the corporation is: 6629 Pembroke Road, Pembroke Pines, Florida 33023.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE
