## ARTICLES OF INCORPORATION OF ZALEZ PHOTOGRAPHY INC.

THE UNDERSIGNED, for the purposes of forming a corporation under the Elgrida General Corporation Act, do hereby adopt the following Articles of Incorporation.

#### **ARTICLE ONE**

The name of the Corporation is: ZALEZ PHOTOGRAPHY INC.

### **ARTICLE TWO**

The duration of the Corporation is perpetual.

#### **ARTICLE THREE**

The general purposes for which the Corporation is organized are the following:
