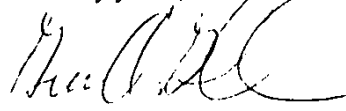

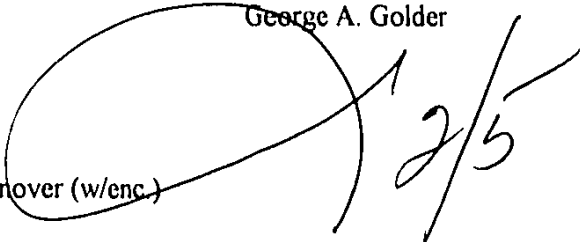

**ARTICLES OF INCORPORATION
OF
SCHOONEY TRUCKING COMPANY**

THE UNDERSIGNED, acting as sole incorporator of **SCHOONEY TRUCKING COMPANY** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

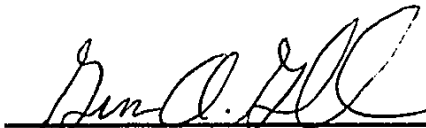
ARTICLE VII

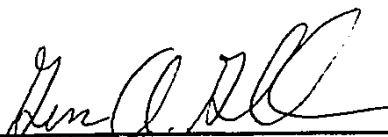
