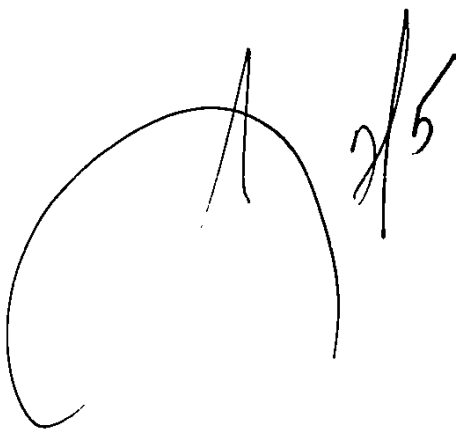

ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Cash Mart Inc.

ARTICLE II

The existence of the corporation shall begin on February 1, 1997.

ARTICLE III

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100 (One Hundred), all of which shall be Common Shares. 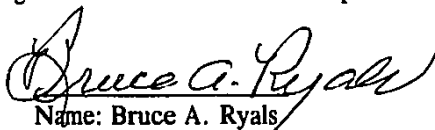
The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
