ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of PATGO ADMINISTRATION COMPANY, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is PATGO ADMINISTRATION COMPANY, INC.

ARTICLE II. ADDRESS

The mailing address of the corporation is 4770 Biscayne Boulevard, #PH-G, Miami, Florida 33137.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 100 shares of common stock having One Dollar (\$1.00) par value.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 4770 Biscayne Boulevard, #PH-G, Miami, Florida 33137 and the name of the corporation's initial registered agent at that address is Henry Gomez.

ARTICLE VII INITIAL BOARD OF DIRECTORS

The corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The name and street address of the initial directors are:

ARTICLE VIII. INCORPORATOR


ARTICLE IX. BYLAWS


