**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

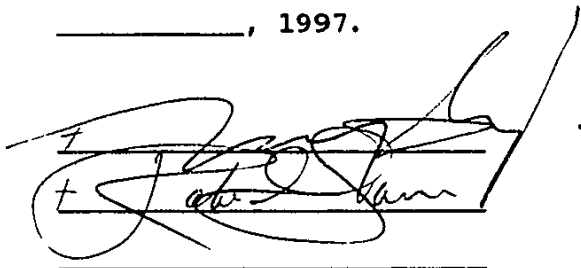
ARTICLE X - INDEMNIFICATION

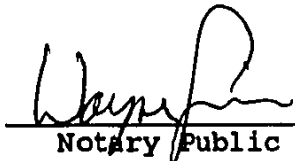
