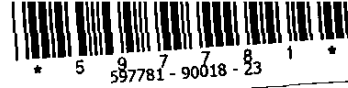

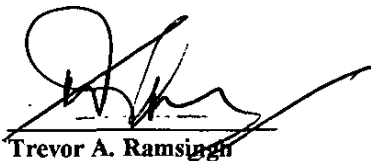
Gentlemen,
