The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is **HOME RESEARCH SERVICES, INC.**

3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

4. **Capital Stock.** The corporation is authorized to issue ONE THOUSAND (1,000) shares, all of one class, at ONE ONE-HUNDREDTH OF A DOLLAR (\$.01) par value. 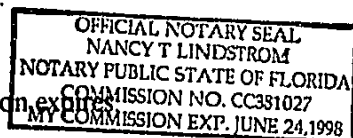
