ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is MAKOS VETERINARY SERVICES, INC. and its principal place of business shall be located at 901 S.E. 17th Street, Suite 206, Ft. Lauderdale, Florida 33316.
