

ARTICLES OF AMENDMENT OF T. RHETT SMITH, P.A.

We, the President and the Secretary of T. Rhett Smith, P.A., a professional service corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

- (1) The name of the Corporation is T. Rhett Smith, P.A.
- (2) The following amendment has been adopted in accordance with the requirements set forth in Chapters 607 and 621 of the Florida Statutes:

Article I of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following new Article I:

## ARTICLE I

The name of the corporation shall be Smith & Janes, P.A.

- (3) The date of the adoption of this amendment is the 30th day of December, 2002.
- (4) The Corporation has only one class of stock, such that there is only one voting group entitled to vote on this amendment. The number of votes cast for this amendment by such voting group was sufficient for approval by said voting group.
