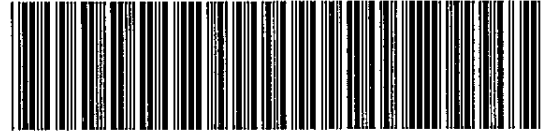

ARTICLES OF AMENDMENT OF

We, the President and the Secretary of Smith & Janes, P.A., a professional service corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

(1) The name of the Corporation is Smith & Janes, P.A.

(2) The following amendment has been adopted in accordance with the requirements set forth in Chapters 607 and 621 of the Florida Statutes:

Article I of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following new Article I:

The name of the corporation shall be T. Rhett Smith, P.A.


(3) The date of the adoption of this amendment is the 29 day of October, 2003.
