## ARTICLES OF INCORPORATION

OF

## SALEM MARKETING INC.

ARTICLE I- NAME: The name of this corporation is SALEM MARKETING INC.

<u>ARTICLE II- DURATION:</u> This corporation shall have perpetual existence commencing on the 5th day of February, 1997.

ARTICLE III-PURPOSE: This corporation is organized for the purpose of sales and marketing and for the conduct of any and all lawful business, and this corporation shall have all powers to effect its purpose.

ARTICLE IV- CAPITAL STOCK: This corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock.

ARTICLE V- RIGHTS OF SHARES OF CAPITAL STOCK:

The assets of this corporation shall be payable to and distributed ratably among the holders of record of the common shares.

Section 2. Voting Rights.

ARTICLE XII - SHAREHOLDER QUORUM AND VOTING: Fifty percent (50%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders.

<u>ARTICLE XIII - APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER:</u> The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law. Said approval may be made at a meeting of the shareholders or in writing as provided by law.

<u>ARTICLE XIV - RIGHTS OF SHAREHOLDERS TO DISSENT</u>: The shareholders of this corporation shall have the right to dissent from any corporate actions from which shareholders are entitled to dissent. <u>Article XV - SHAREHOLDERS MEETING REQUIRED</u>: Any action of the shareholders of this corporation must be taken at a meeting of shareholders of this corporation, duly called as provided by law, unless written consent by holders of 75% of all issued and outstanding shares is obtained.

<u>ARTICLE XVI - MANAGEMENT OF CORPORATION BY SHAREHOLDERS:</u> All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation until corporation, partnership, joint venture, trust or other enterprise, unless approval is given by 2/3 of the holders of the outstanding common stock.

<u>ARTICLE XVIII - DIRECTORS COMPENSATION:</u> The shareholders of this corporation shall have the exclusive authority to fix the compensation of directors of this corporation.

<u>ARTICLE XIX - NO REMOVAL OF DIRECTORS</u>: The shareholders of this corporation shall not be entitled to remove any director from office during his term, unless otherwise provided by the laws of the State of Florida and the Florida General Corporation Act. <u>ARTICLE XX - MEETINGS BY CONFERENCE TELEPHONE</u>: Members of the Board of Directors may participate in meeting of the Board of Directors by means of conference telephone as provided by law. <u>ARTICLE XXI - ACTION BY DIRECTORS WITHOUT A MEETING</u>: The directors of this corporation may take action by written consent, as provided by law.
