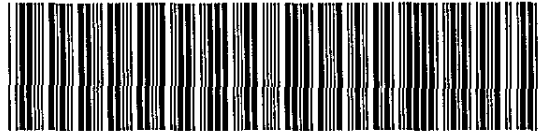

ARTICLES OF AMENDMENT
