ARTICLE I. NAME

The name of this corporation is CULTURED MARBLE & GRANITE

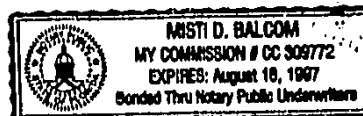
