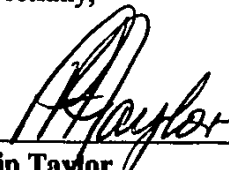

ARTICLE ONE

The name of the corporation is **TAYLOR & SONS MANAGEMENT CONSTRUCTION, INC.**

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**

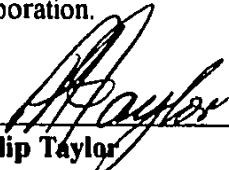
ARTICLE FIVE
